

## **HANDGUN RANGE AND ARCHERY TOWER**

### **GENERAL:**

1. There will be no handgun shooting at archery targets and no archery shooting at handgun targets.
2. Only club members in good standing may use this facility. Guests or non-members are not permitted to use the range. A guest must be accompanied by a member in good standing: that member will be responsible for their guest's actions.

#### **A. HANDGUN RANGE**

1. Shooting time is 8 AM until one-half hour after sunset every day.
2. No fully automatic weapons are permitted.
3. There is no restriction on handgun calibers or rapidity of firing.
4. Human silhouette targets are permitted for practice in self defense shooting.
5. Shooting is restricted to the pavilion. No targets other than the four target boards will be used.
6. If two or more shooters are using the range, they will establish a range officer to coordinate shooting and posting/checking targets.
7. Shooters must be respectful and considerate of each other.
8. If the archery tower and the handgun range are in use simultaneously, shooters must coordinate with each other for mutual protection.
9. When finished, shooters will remove all brass, trash and targets.

#### **B. ARCHERY TOWER**

1. Shooting time is 8 A.M. until one-half hour after sunset every day.
2. Shooting is restricted to the 3D targets. Shooters may move those targets, but not into the field of the handgun range when in use. Targets must be placed off the range when shooting is completed.
3. Shooters may fire at ground level and from the handgun range when that range is not in use.
4. Shooters must be respectful and considerate of each other.
5. When finished, shooters must remove all trash.

## **GROUND RULES**

1. No-one under the influence of drugs or alcohol will be permitted on the grounds.
2. No drugs or alcohol will be permitted on the grounds, whether locked in a vehicle or otherwise secured.
3. All shooting on club grounds will be restricted to the appropriate range (rifle/handgun/archery) and will be limited to the established target facilities.
4. All shooting ranges shall be closed two hours before, during and after any social activities. During scheduled special events, all ranges will be closed for the entire day.
5. Junior members under 16 years of age shall not be allowed to discharge any firearms unless accompanied by an adult member in good standing.
6. Guests will be permitted to accompany an adult member in good standing, but are excluded from using the shooting and fishing facilities.
7. Club keys are available to all adult members in good standing for a fee of \$20/year or until the locks are changed and can be obtained from any officer or director. Directors have the right to deny a key to any person they deem to be a risk.
8. Open hunting and fishing, by members only, will be allowed on the grounds. Appropriate licenses are required. Safety zones around buildings must be obeyed.
9. No loaded firearms will be permitted in the clubhouse, except during block shoots, and they must be loaded only when extended out of designated windows.
10. There will be no social activities while the monthly meeting is underway.
11. All work on property grounds will be planned and completed by the Buildings and Grounds Committee. All recommendations from members are welcome.
12. Loan and use of club buildings and property will be limited to that approved by the Board of Directors.
13. No unattended fires will be allowed. No fires will be allowed within 50 feet of any building.
14. No member under the age of 18 may camp on club grounds without the presence of an adult member in good standing.
15. Anyone who is caught willfully destroying or damaging club property will be dealt with by the board of Directors and/or by legal action.
